## 3. Profile of skills and competences

1. Know the main technical features, management procedure, operation, safety devices, construction, and main systems of lifts; the construction and operation of hydraulic systems; the types of and schedule for maintenance and repair work; and the structure, regulatory norms, and lubrication schedule of lifts;
2. Know the possible faults of lifting mechanisms, causes of these faults, and methods to eliminate such faults;
3. Know the requirements for the erection of automated lifts and organization of work from the platform of an automated lift;
4. Know health and safety instructions for an automated lift machinist;
5. Know the main causes of the accidents that occur while working with automotive lifts;
6. Be able to manage and operate automated lifts safely;
7. Be able to perform automated lift maintenance work and identify and eliminate simple operating faults;
8. Be able to read drawings and schemes included in the lift user's manual;
9. Observe requirements for employees' health and safety, fire prevention measures, and electric and environmental safety.

## 4. Range of occupations accessible to the holder of the certificate<sup>1</sup>

Can work with automated lifts at construction sites and other objects; perform construction, renovation, decoration, installation, dismantlement, and other high-rise work; perform transportation and warehousing work; and perform technical maintenance of automated lifts.
