Distinguish the right and wrong side of the fabric and set the direction of longitudinal thread. 7. Take measurements of the shape of a body. 8. Prepare a garment for fitting, and fit and adjust it according to the shape of the body. 9. Cut parts of a garment and inspect the quality and markings of the parts. 10. Sew components of garments. 11. Eliminate possible defects of sewing. 12. Perform finishing of a garment and steam iron it.
