- 5. Operate harvesting and product processing machinery and adjust, diagnose and repair their faults; assemble and operate tractor assemblies, prepare tractors and agricultural machinery for storage and use.
- 6. Apply agro-technical requirements in tillage, sowing, planting, plant care, harvesting and product processing works.
- 7. Work safely and apply environmental protection requirements.
- 8. Adjust trailers and their nodes, diagnose and repair their faults.

Can work as a driver (tractor driver) in a personal holding and for various agricultural companies operating up to 60 kW engine wheeled agricultural and forestry tractors, crawler tractors, combination vehicles (tractors with trailers), and agricultural machinery.
