#### 3. Profile of skills and competences

- 1. Understand the schemes of the heating equipment that is maintained and read working drawings and schemes;
- 2. Know the peculiarities of the construction and installation of technological heating equipment;
- 3. Exploit and maintain steam and hot water pipelines, heat consuming devices, and the equipment of condensation collection systems;
- 4. Exploit and maintain reinforcement, protective installations, and regulatory, metering and automatic devices;
- 5. Prepare technological heating equipment for operation (with the exception of boilers);
- 6. Stop the operation of technological heating equipment (with the exception of boilers) in an emergency;
- 7. Disconnect and stop the operation of heating equipment in consideration of meteorological conditions;
- 8. Prepare gaskets and assemble flange joints, replace and tighten spacers, seal muff joints, and replace manometers;
- 9. Handle working documents;
- 10. Observe the requirements for employees' health and safety and provide first aid to the injured.

## 4. Range of occupations accessible to the holder of the certificate1

Can work as an employee maintaining technological heating devices in enterprises engaged in the maintenance of equipment producing, consuming, transmitting, distributing, accumulating and reducing heat.
