7. Control technological parameters according to technological regulations.
8. Enter the readings of measurement devices into a shift logbook.
9. Prepare technological equipment for repair and perform minor repair of equipment and the infrastructure.
10. Stop the unit in emergency situations and eliminate the consequences of accidents according to an emergency action plan.
11. Use personal protective equipment.
12. Render first aid to injured parties.
