- 2. Maintain regulatory and measurement devices and automation equipment and select and adjust the operational modes and parameters of regulatory and measurement devices.
- 3. Read and understand the technical projects of gas mains and their equipment and technological and principal schemes.
- 4. Understand the operation of gas compressor stations and gas distribution stations.
- 5. Know the purpose and installation of anticorrosion protection for gas pipes.
- 6. Know the operation and adjustment of gas mains, compressor stations, and automation systems of gas distribution stations (safety, regulation, signalling, and blocking).
- 7. Identify and assess risks at work and take preventive measures within the area of one's competence and make decisions in case of an accident.
- 8. Manage work records.
- 9. Observe health and safety requirements and render first aid to injured parties.

4. Range of occupations accessible to the holder of the certificate¹

The holder may organise and manage the maintenance of gas mains, regulatory and measurement devices, and automation equipment.
