## 3. Profile of skills and competences

1. Know the main technical features, management procedure, operation, safety devices, and main systems of truck-cranes; the composition of hydraulic systems; the operation and composition of mechanisms; norms for regulation; and the lubrication schedule for truck-cranes;
2. Know possible crane faults, the causes for such faults, and methods to rectify the faults and the main causes of accidents while working with truck-cranes;
3. Know the requirements for erecting cranes and the rules for operating lifting devices and truck-cranes;
4. Know the instructions for the use of cranes, the technical maintenance and repair system of cranes, and health and safety instructions for a truck-crane machinist;
5. Be able to manage truck-cranes and perform the lifting of loads and construction and erection work;
6. Apply the signals used in load lifting work and observe the requirements for strapping, moving and storing loads;
7. Perform crane maintenance work and eliminate simple faults and read drawings and schemes included in the crane user's manual;
8. Observe the requirements for employees' health and safety, fire prevention, and electric and environment safety.

## 4. Range of occupations accessible to the holder of the certificate<sup>1</sup>

Can work with truck-cranes at construction sites and in warehouses, perform load lifting, transporting and warehousing work, and perform the technical maintenance of cranes.
