## 3. Profile of skills and competences

1. Know installation and operation of steam (up to 0.07 MPa) and water (up to 115°C) boilers and auxiliary equipment, and installation of pipe systems.
2. Know properties of solid and liquefied fuel and conditions for burning and storing the fuel.
3. Know procedures for operation and maintenance of steam and water boilers.
4. Be able to prepare steam (up to 0.07 MPa) and water (up to 115°C) boilers heated with solid and liquid fuel for work prior to switching them on, and switch on/off the boilers as required.
5. Maintain and regulate water and steam temperature, pressure, and the level of water in the boiler.
6. Use fuel economically and maintain and regulate burning.
7. Prepare solid fuel, load it into the fire box, and remove cinder and ashes.
8. Switch on/off pumps, ventilators, and other auxiliary equipment and monitor them during the burning process.
9. Prepare boiler for the summer season.
10. Observe health and safety and fire safety requirements.

## 4. Range of occupations accessible to the holder of the certificate<sup>1</sup>

The holder may work as an operator in boiler rooms of steam (up to 0.07 MPa) and water (up to 115°C) boilers heated with solid and liquefied fuel
