- 7. Perform finishing works on leather goods.
- 8. Prepare textile products for giving back.

- 1. To choose materials, tools and equipment for repair of textile products.
- 2. Repair textile products.
- 3. Accept an order to perform a textile care service.
- 4. To issue a textile product after a care service.
- 5. To clean single piece textiles.
- 6. Perform finishing work on single-piece textile products.

## 4. Range of occupations accessible to the holder of the certificate<sup>1</sup>

The object of a textile care worker: Provision of washing, wet cleaning, dry cleaning, ironing of various textile products, skin care works according to process technological requirements and the rules for dry cleaning and laundry services; ensuring the economical use of material resources.
