14. Mend un-lined shouldered clothes.
15. Perform final sewing works of un-lined shouldered clothing.
16. Cut details of lined shouldered clothing.
17. Process and sew details of lined shouldered clothing.
18. Combine details of un-lined shouldered clothing with lining.
19. Mend lined shouldered clothes.
20. Perform final sewing works of lined shouldered clothing.
21. Accept sewing service order.
22. Sew custom tailored clothes.
23. Perform final sewing works of clothing.

Upon acquiring the qualification, the individuals will be able to work in companies providing clothing sewing and mending services as well as to sew clothes for sewing companies or individually, will be able to work with different kinds of sewing, cutting and moisture thermal processing equipment, will be knowledgeable about the technical condition of the equipment, will be able to prepare it for the job in accordance with technological requirements, to sew and custom-fit garments, to mend and design clothing.
