### 3. Profile of skills and competences

- 1. To know technology of replacing metal constructions and mechanism in a crane.
- 2. To know methods of repairing and renovating parts of a crane.
- 3. To determine a depreciation level of those parts of a crane that are subject to fast depreciation and to determine whether they are suitable.
- 4. To replace mechanisms of a crane or their parts.
- 5. To determine suitability of a crane's cables.
- 6. To replace a crane's cables by connecting ends.
- 7. To inspect functioning of a crane's safety devices and to eliminate defects.
- 8. To find causes of a crane's failures.
- 9. To perform repairs of a crane in a safe manner.
- 10. To know lubrication diagrams and a frequency of lubrication.
- 11. To change lubricant in mechanisms.
- 12. To prepare a crane for a technical inspection.
- 13. To locate crane railway defects and to eliminate them.
- 14. To use personal protection means.
- 15. To provide first aid to a victim.

### 4. Range of occupations accessible to the holder of the certificate<sup>1</sup>

To repair, adjust and inspect cranes in crane repair workshops, bays, construction objects that use cranes.
