<p>A person who has acquired the ship systems and equipment assembler skills, will be able to work as systems and equipment installers in shipbuilding and ship repair companies, industrial and civil engineering, in installation companies or to engage in individual activity. Team work shifts indoors and outdoors. The work is guided by the technical documentation, using the locksmith tools, pipe preparation, bending devices and equipment, cutting and welding equipment, hydraulic testing equipment, ship equipment and heat exchangers. An employee schedules activities according to the given tasks using the help of a higher qualified employee.</p>
