- 6. To install fastening for devices, pipes and sanitary appliances;
 7. To seal muff connections on cast iron pipes;
- 8. To assemble plumbing systems from plastic materials;
- 9. To manually screw threads, drill holes, prepare ends of pipes for welding, cut various pipes, and collect plumbing systems and prepare them for testing;
- 10. To disconnect water heating boilers from the system and to install various reinforcements and repair them.
