- 6. To collect and neutralize spilled chemical substances.
- 7. To use gas analysis devices.
- 8. To assess hazards and risks when working with poisonous and hazardous chemical substances and to take preventive measures within one's competence.
- 9. To use personal protection means.
- 10. To provide first aid to a victim.
