Competences of qualification:

1. To protect human rights and freedoms.

5. To restore public order and peace, and use coercive measures, if necessary.
6. To provide assistance to persons who are physically or mentally incapacitated, as well as persons who have fallen victims of criminal or administrative offences, emergencies and other similar factors.
7. To carry out criminogenic assessment, monitoring and control of public places.
8. To protect objects which are important from the point of view of public security.
9. To implement individual prevention measures, as well as to control obligations and prohibitions imposed on persons.
10. To supervise persons brought to a police agency and held in police custody, and to convoy persons.
11. To carry out mobile control of traffic safety.
12. To qualify and investigate administrative offences.
13. To perform initial actions at the place of the incident.
