3. Familiarize ship's passengers with procedures for safe handling during emergencies.
4. Maintain and clean the ship's premises.
5. Clean various surfaces and coatings. 6. Monitor the condition of equipment and inventory in passenger accommodation.
7. Prepare the catering room and location.
8. Provide drinks and meals to ship passengers.
9. Provide food and drink to the ship's passengers in the accommodation.
10. Keep records of sales, economic assets, material values and financial documents.
11. Store different groups of goods.
12. Make and serve mixed drinks and cocktails.
13. Bottle and serve alcoholic and non-alcoholic beverages.
14. Make and serve hot drinks.
15. Prepare and serve simple cold and hot snacks.
16. Describe the organization of the service on board, the structure and equipment of the ship.
17. Survive at sea by leaving the ship.
18. Assess the risk of fires, reduce it.
19. Extinguish and extinguish fires.
20. Take appropriate action in the event of an accident or other injury.
21. Take precautionary measures against pollution of the marine environment.
22. Eliminate accidents on board.
23. Follow safe working procedures and ship security plan.
24. Assist in ensuring effective communication on board.
25. Assist in ensuring effective human and labor relations on board.
26. Assess the effects of fatigue and take appropriate action to control fatigue.
