- 2. Know maintenance rules of compressors, pressure vessels, and pipe systems; maximum running temperature of compressors and auxiliary equipment, and causes for overheating and their elimination.
- 3. Ensure reliable operation of compressors and auxiliary equipment, monitor compressors during operation, and complete the required documentation.
- 4. Identify and eliminate interruptions in compressor operation.
- 5. Add/remove oil.
- 6. Observe health and safety, fire safety, and hygiene requirements.

The holder may work as a compressor operator in companies using small power compressors.
