- 8. Take care of sick children and render first aid.
- 9. Understand the process of organising household management.
- 10. Select the correct food and feed a child according to age, development, and health.
- 11. Develop the internal abilities of a child which determine normal personality development.
- 12. Know food preparation technology and know how to lay a table and serve food.

The holder may work at agencies and organisations providing social services to social risk family groups or families that have problems of socialisation; the holder may also work at agencies and organisations working with elderly and disabled people.
