- 4. Inspect the condition of boilers and identify and eliminate breakdowns.
- 5. Organise repair work of boilers and auxiliary equipment of boiler rooms.
- 6. Perform technical inspection of boilers.
- 7. Observe health and safety, fire safety, and hygiene requirements.
