3. Profile of skills and competences

Competences of a security worker:

- 1. To protect premises, territories and property inside;
- 2. To foresee actions and to take actions in cases of violations of safety of an object;
- 3. To protect persons;
- 4. To protect property;
- 5. To ensure safe transportation of property;
- 6. To use physical violence, special means and firearms;
- 7. To perform entrance security and control;
- 8. To ensure security in massive events and to coordinate actions with police officers and officers of special services;
- 9. To provide help in extreme situations.

A security worker needs the following general skills:

self-reliance, emotional stability, discipline, good organization, physical fitness and stamina, dutifulness, a sense of personal responsibility, being helpful, communicability, ability to make decisions and willingness to improve.

4. Range of occupations accessible to the holder of the certificate1

Having acquired a qualification of a security worker, a person can work as a security worker in private security services and structural divisions.

Fields of activities: protection of objects; protection of persons and property; security in events.
