2. Equip zones (parks) of construction, repair and maintenance.
3. Select and storage materials.
4. Read the road construction execution drawings.
5. Perform preparatory measurements and markings of construction work.
6. The drive tractors of TR1 category and SM categories of machinery.
7. To work with the SM category earthworks and earth-moving equipment.
8. Install subgrade and perform other excavation work.
9. Equip the road basics.
10. Lay the road cover and treat its surface.
11. Perform installation of hydraulic road structures.
12. Perform road maintenance work.
13. Perform road repair work.

## 4. Range of occupations accessible to the holder of the certificate<sup>1</sup>

Carry out preparatory measurements necessary for road construction work, carry out soil excavation, road bed and road band preparatory work, prepare the road base, lay various road surfaces (of gravel, crushed stone, asphalt, concrete and asphalt), treat the surface of cover, mount various concrete and reinforced concrete road construction, water draining devices, carry out road repair works (road surface milling, levelling, potholes patching, etc.), install fences and other elements of road marking, work with special excavation, transportation, road paving preparation and maintenance machines, self-propelled road construction machinery.
