A person who acquires the qualification of floor layer must be able to assess the condition of flooring, and prepare materials, tools, and equipment; use mechanical and power tools, know and implement floor covering design, prepare base surface, lay floor, and maintain the surface.

A person who has acquired the qualification of floor layer may work at various construction companies, establish their own company, and work individually; lay PVC and natural linoleum floor covering.
