### Profile of skills and competences

- 1. Perform and assess arable farm work (ploughing, harrowing, cultivation, etc.), calculate the demand for seeds, and sow, plant, and look after plants; eliminate weeds, harvest and store products, and maintain irrigation equipment.
- 2. Assess fodder according to external features, determine the amount of fodder for cattle and poultry, prepare fodder and feed cattle and poultry, milk cows, identify the condition of livestock, and prepare livestock for slaughtering and meat and milk for storage and transportation; keep and maintain cattle and poultry, and breed livestock.
- 3. Take care of ailing livestock, produce and use dietary fodder, prepare livestock for parturition and provide assistance during normal parturitions.
- 4. Calculate efficiency of equipment and the amount of materials required for use of equipment; assess quality of work, and maintain records of mechanised work performed.
- 5. Assess the amount of stock for production, record income and expenses, assess farming product and raw material markets, and plan the amount of production and investment.
- 6. Know the main types of wood (coniferous and deciduous trees), and determine the amount of logs, firewood, processed timber, and standing trees.

### 4. Range of occupations accessible to the holder of the certificate1

The holder may work as an arable farmer, livestock farmer, or forest supervisor.
