8. Calculate the balance of mineral elements in the soil.
9. Apply natural means to ensure fertility of the soil and protection of the plants against pests and diseases.
10. Apply ecological soil preparation methods and techniques, and prevent soil erosion.
11. Ensure work and fire safety on a farm.
12. Estimate the demand for fodder and supplements for cattle and poultry.
13. Manage manure and prepare compost.
14. Prepare products for sale and assess and conclude purchase-sale agreements.
