1. Know systems and methods for raising livestock.

3. Know quality requirements for milk and create conditions for the production of high quality milk.
4. Take milk samples of the control group and complete the required documents.
5. Manage accounting of individual herds of livestock.
6. Identify rutting season of cows and heifers.
7. Assess the quality of fodder according to external features.
8. Complete a feeding schedule including amount of fodder, sequence and frequency of feeding, etc.
9. Organise supplements for livestock of different ages and purposes.
10. Estimate the expenditure for fodder and the price of fodder per unit of production.
11. Apply measures for disease prevention and assist during parturitions of cows.
12. Wash and disinfect milking machines, milk systems, and milk storage equipment.
13. Ensure appropriate microclimate of barns.
14. Ensure pollution-free manure management.
15. Manage revenue/expenses accounting.
