Organise construction of a gas pipe system (technical conditions, geodesic research, topographic photos, and permits). 6. Know classification of gas mains, the purpose of a compressor station, and equipment, technical parameters, and protective zones of the station. 7. Prepare a trench for a pipe system, lay and fit pipes, and organise installation of gas distribution, compressors, gas meter units, and equipment. 8. Install gas burning appliances and elimination systems for burning products. 9. Install gas regulation units and internal gas lines, and manage work records. 10. Observe health and safety requirements.
