- 5. To understand welding of steak and polythene gas pipelines and soldering of copper pipes.
- 6. To use gas accounting, control and measuring devices.
- 7. To do main metalworking.
- 8. To install gas pipelines, their equipment and devices.
- 9. To insulate gas pipelines.
- 10. To file work documents.
- 11. To assess and determine risk at work and to take preventive measures within one's competence.
- 12. To provide first aid to a victim.
- 13. To meet occupational safety and health requirements.
