8. Applying make-up.
9. Evaluating the state of hand and foot skin and finger and toe nails and selecting appropriate procedures for the skin and nail care.
10. Performing non-invasive skin care procedures on healthy hand and foot skin.
11. Performing healthy nail manicure.
12. Performing healthy nail pedicure.
13. Evaluating the state of facial and body skin before performing depilation procedures and selecting appropriate cosmetics and the depilation procedure.
14. Performing depilation.

### Optional competencies:

1. Evaluate nail condition and choose tools for nail art.
2. Do nail art.
3. Evaluate nail condition and select tools, technologies for artificial nail extension.
4. Extend artificial nails.
5. Select tools for body painting.
6. Perform body painting.
7. Choose the tools to extend the eyelashes.
8. Extend eyelashes.
9. Evaluate the beauty service environment.
10. Organize beauty service activities.

## 4. Range of occupations accessible to the holder of the certificate<sup>1</sup>

A person with the qualification of a cosmetician may work individually or in the institutions offering beauty services (beauty parlours, cosmeticians office, spas etc). A cosmetician is able to use cosmetics equipment, tools and instruments intended for non-invasive skin care procedures.
