4. Know components and operation of tillage, sowing, planting machinery, plant protection, harvesting and product processing machinery; operate, adjust, diagnose and repair their faults.
5. Assemble and operate tractor assemblies and combination vehicles.
6. Prepare tractors and agricultural machinery for storage and use.
7. Work safely and apply environmental protection and agro-technical requirements.
8. Know components and operation of trailers and their nodes; adjust, diagnose, repair their faults and perform maintenance.
9. Know components, operation, adjustment, diagnostics and control of category TR2 tractors with special integrated equipment (excavators, bulldozers, loaders).

## 4. Range of occupations accessible to the holder of the certificate<sup>1</sup>

Can work as a driver (tractor driver) in a personal holding and for various agricultural companies operating up to 60 kW engine wheeled agricultural and forestry tractors, crawler tractors, combination vehicles (tractors with trailers), and agricultural machinery.
