6. To repair various footwear;
7. To locate defects of small wares;
8. To choose and adjust materials and elements for repairing leather small wares;
9. To repair small wares.

**A repairer of leatherwear needs the following general skills: focus; persistence; physical stamina of hands; accuracy; personal responsibility; being helpful; creativity.**

A repairer of leatherwear can work:  
in companies providing footwear and small ware repair services,  
individually.
