7. Sand down various surfaces.
8. Select and prepare paint.
9. Paint an auto body and its parts.
10. Assess the quality of the finish and painting.
11. Apply anti-corrosion underneath the auto body.
12. Polish an auto body.
13. Use tools and equipment.
14. Observe health and safety requirements.
