### Qualification making competencies:

1. Store the materials, products, equipment for facade insulation.
2. Prepare the work area for facade insulation work.
3. Read the building work project.
4. Read work drawings.
5. Prepare the surfaces for heated facades.
6. Fix the thermal insulating material.
7. Adjust a decorative plaster in a hand manner.
8. Paint building facades.
9. Fix the tin facade elements.
10. Adjust a decorative plaster in a mechanical manner.
11. Finish facades with tiles.

## 4. Range of occupations accessible to the holder of the certificate<sup>1</sup>

A person who has acquired the facade heater qualification will be able to work in construction companies or perform individual activities. Working conditions: working in building and outside with environmental and human aggressive materials, hazardous hand and electric tools; have to work at height; the working environment may be dusty, dirty, depending on weather conditions. At work have to wear special work wear. The employee must go under a health preventive check and have a personal medical record or a medical certificate for compulsory medical examination.
