## 3. Profile of skills and competences

### Competences of qualification:

1. To prepare the workplace for metalworking performing.
2. To use measurement tools and devices.
3. To perform metalworking operations by using manual and mechanized tools and equipment.
4. To perform works by manual electrolytic arc welding electrodes.
5. To weld pipe joints in various spatial positions.
6. To prepare the workplace for gas and plasma metal cutting.
7. To mark sheets, tubes, profile incisions places.
8. To perform gas and plasma metal cutting operations.
9. To prepare the workplace for ship systems assembling.
10. To select structural elements for installation of onboard and deck equipment.
11. To weld the mounting details on the ship hull.
12. To prepare the place for the ship systems pipes preparation and assembly of nodes.
13. To mark and cut pipe systems of ships.
14. To bend the pipes of the ship systems.
15. To process pipe ends for different pipe connection types.
16. To prepare for hydraulic testing of ship pipe systems.
17. To select structural elements of piping assemblies according to technical documentation.
18. To assemble pipeline nodes.
19. To install of ship systems on board.
20. To carry out dismantling and marking of ship systems on board.
21. To eliminate defects repairing pipes and fittings in the workshop.
22. To install and dismantle the ship equipment and heat exchangers.
23. To perform restoration of heat exchangers.
24. To perform repairs of pumps, coolers and heaters.

### Optional:

25. To prepare pipe joints for semi-automatic welding with a fusible electrode in a protective gas environment.
26. To weld pipe joints using coupling in various positions by an electric arc semi-automatic welding with a fusible electrode in a protective gas environment.
27. To prepare pipe joints for pipe welding with a non-fusible tungsten electrode in a protective gas environment.
28. To weld pipe joints using coupling in various positions with a non-fusible tungsten electrode in a protective gas environment.

## 4. Range of occupations accessible to the holder of the certificate<sup>1</sup>

The work is guided by the technical documentation, using the locksmith tools, pipe preparation, bending devices and equipment, cutting and welding equipment, hydraulic testing equipment, ship equipment and heat exchangers. An employee schedules activities according to the given tasks using the help of a higher qualified employee.
