### Competences of qualification:

1. Ensure the patient's personal hygiene.
2. Assist with feeding the patient.
3. Care for patient's entire body cleanliness.
4. Familiarize the patient with a temporary living environment of health care institution.
5. Take care of dying patients and their families.
6. Assist the nurse to prepare and carry out patient's rehabilitation procedures.
7. Provide assistance in carrying out procedures and patient's care.
8. Collect simple samples for testing, to pack and deliver them to the laboratory.
9. Take care of vomiting, probed and drained patient, to maintain catheter and monitor urine output as well as patient's defecation and urination processes.
10. Prepare and use of disinfectants.
11. Monitor the infusion, to prepare and maintain the care measures.
12. To manage dead bodies.

## 4. Range of occupations accessible to the holder of the certificate<sup>1</sup>

The target activities of the nurse assistant is: assurance of patient's hygienic needs, caring for patients and their families, feeding the patients, management of patients' discharge and secretions, assistance in movement and technical work.
