<b>A person who acquires the qualification of plasterer must be able to inspect and mark surfaces, place markings, plaster surfaces with rough and finish coats, plaster facades, identify and eliminate plaster defects, and repair plaster; use all the protective means to perform plastering or plaster repair safely, use protective measures during the winter time, and be able to install window sills and flashings according to requirements.</b>

4. Range of occupations accessible to the holder of the certificate <sup>1</sup>
A person who has acquired the qualification of plasterer may work at various companies performing exterior finishing work, or acquire a business certificate and work individually.
