<b>A person who acquires the qualification of tiler must be able to read work drawings, work safely on a site, and know the basics of law, economics, and labour law; prepare his/her working area, mark surfaces by using geodesic equipment, prepare mortar or adhesive for tiling, prepare surfaces for tiling, cut tiles, drill holes in tiles, affix tiles to horizontal and vertical surfaces using various methods, grout tiles, apply sealants, level the floor, and plaster using hand tools.</b>

4. Range of occupations accessible to the holder of the certificate <sup>1</sup>
A person who has acquired the qualification of tiler may work as a tiler at various construction companies, or acquire a business certificate and work individually.
