4. Assist the nurse or obstetrician in caring for a patient.
5. Assist the nurse to prepare and carry out patient's rehabilitation procedures.
6. Take care of dying patients and their families.
7. Collect simple samples for testing, to pack and deliver them to the laboratory under supervision of nursing specialist.
8. Take care of vomiting, probed and drained patient, to maintain catheter and monitor urine output as well as patient's defecation and urination processes.
9. Prepare and use of disinfectants.
10. Monitor the infusion, to prepare and maintain the care measures.
11. Manage dead bodies.
