A person who has acquired the finish installer qualifications will be able to work in construction companies or perform individual activities. Working conditions: working in building and outside with environmental and human aggressive materials, hazardous hand and electric tools; have to work at height; the working environment may be dusty, dirty, depending on weather conditions. At work have to wear special work wear. The employee must go under a health preventive check and have a personal medical record or a medical certificate for compulsory medical examination.
