Assemble furniture from sheet materials. 11. Cut solid timber for furniture. 12. Carry out secondary operations for the preparation of solid timber blanks and parts for furniture production. 13. Assemble furniture from solid timber blanks. 14. Produce wicker furniture elements. 15. Cut upholstery, layers of foam and additional upholstery materials. 16. Form and glue softening and additional materials for the production of upholstered furniture. 17. Assemble and upholster upholstered furniture.
