6. Mark and assemble parts for sewing according to the documentation of the garment.
7. Perform manual stitching.
8. Make various types of stitches and use them as designated.
9. Sew the components of various parts.
10. Assemble separate parts to form a garment.
11. Operate various sewing machines and wet and thermal processing equipment.
12. Use the equipment, tools and methods of work that ensure high quality products.
13. Perform wet and thermal processing.
14. Evaluate the quality of parts and final products.
15. Prepare parts for storage and sale.
16. Keep financial records and evaluate economic results.

A garment maker can prepare sewing materials and sewing supplements for production process, cut sewing materials and complete details, sew sewing details and connect them to become a product, perform finishing decoration and accounting of the products.
