9. To monitor and provide information about cargo transportation mode;
10. To prepare freight documentation.

### Optional competences:

1. To use personal selling technique;
2. To accept, storage, issue and account goods;
3. To plan and carry out material flow movement of traffic in the production process.

Having acquired the qualification persons will be employed in the transport, logistics and industrial companies, trading companies in shipping, purchasing, order, export, import, agricultural, transport units.
