5. To fix fittings to leather goods.
6. To hand sew leather goods.
7. To machine sew leather goods.
8. To perform mechanical and chemical leather goods finishing works.
9. To perform decorative works of leather goods.
10. To perform stamping and perforation when preparing leather goods.

### Optional competencies:

1. Sew and assemble a saddle.
2. Sew and assemble a harness and other leather horse ammunition.
3. Manually cut and process parts of a backpack.
4. Make a backpack.

Qualified individuals may work in footwear, haberdashery and other entities engaged in the production of leather goods.
