3. Profile of skills and competences

Competences of qualification:

1. Store heating, ventilation, air conditioning system installation materials, products, equipment.
2. Prepare and arrange the workstation of the heating, ventilation, air conditioning system installer.
3. Read the construction work project.
4. Install water supply, heating-cooling and drainage pipes.
5. Prepare building structures for pipe installation.
6. Install the building's water heating and cooling pipelines and appliances.
7. Install the building's water heating-cooling system equipment.
8. Maintain the building's water heating and cooling pipelines and appliances.
9. Install duct networks.
10. Install ventilation of the building equipment and devices.
11. Install a smoke extraction system.
12. Maintain building ventilation equipment and appliances.
13. Install heat pumps in water systems.
14. Install heat pump systems using F gas and non-halogen refrigeration agents.
15. Monitor heat pump systems.

Optional Competencies:

1. Install the heating station equipment.
2. Maintain heat sub-station.
3. Connect low-pressure (up to 0.05 MPa) and water heating (up to 110 °C) boilers to the building's heating system.
4. Maintain the building's boiler room equipment.

4. Range of occupations accessible to the holder of the certificate¹

A person who has acquired the qualification of heating, ventilation, air conditioning system installer will be able to work in the companies that provide heating-cooling, ventilation, air-conditioning systems installation or to lead their own business. The heating, ventilation, air conditioning system installer (III level of qualification system) carries out work under the guidance of a higher qualified person. The heating, ventilation, air conditioning system installer adheres to the requirements of safe working, electrical, ergonomic, environmental, sustainability requirements and laws, heating, ventilation, air conditioning system installer installs heating and cooling systems and appliances for the building, installs ducts, installs equipment and appliances for building ventilation systems, installs heat pumps, prepares and tidies up workstations, prepares materials and prepares materials. tools, locksmithing, storing materials, reads the construction drawings and schemes. Heating, ventilation, air conditioning system installer's work is usually in households, residential communities, businesses, industrial building.
