2. To know requirements of normative documents regulating installation and technical maintenance of electrochemical protection against gas pipelines corrosion and a procedure of performing works.
3. To know methods of electrochemical protection against corrosion.
4. To understands actions that must be taken in a case of gas leaks or breakdowns of gas equipment and appliances.
5. To install and technically maintain electrochemical protection against gas pipelines corrosion.
6. To use graphical documentation of gas systems (designs, layout drawings and graphical-information system).
7. To use control measuring devices.
8. To file work documents.
9. To provide a first aid to a victim.
10. To meet occupational safety and health requirements.

To work as a metal worker in gas supply and construction (installation) companies: to install, maintain and repair equipment for electrochemical protection against gas pipelines corrosion.
