1. Safely use mechanical and hand tools, lifting and transportation equipment, and measurement and regulatory devices.
2. Read working drawings and kinematic schemes, and make blueprints of the components.
3. Know physical and mechanical characteristics of materials.
4. Know the characteristics of anti-corrosive, lubrication, and cooling materials and their use.
5. Correctly select the geometry of cutting equipment and sharpen it.
6. Perform metalworking operations to a quality grade of 7-11 and select appropriate sequence operations.
7. Know methods of thermal and thermal-chemical processing.
8. Perform medium complex repair work and identify and eliminate defects of components.
9. Assemble parts after repair, and join and fit parts correctly.
10. Perform medium complexity standard repair of machinery, and repair complex machinery under the supervision of a qualified worker.

## 4. Range of occupations accessible to the holder of the certificate<sup>1</sup>

The holder may perform metalworking operations up to a quality grade of 7-11, and standard and medium complexity repair of machinery.
