The graduate will be able: to till the land for agricultural crops; do the sowing, planting, plant care and harvesting work; grow crops; choose the animals and birds suitable for reproduction and productivity; choose the fodder for livestock and poultry; feed and take care of animals and birds; milk using milking technologies; drive agricultural tractors, self-propelled agricultural machines; do the simple equipment repair and maintenance work; know the basic framework of agriculture, agro-technology, cattle-breeding, agricultural activities, accounting and labour law for occupational safety requirements; be able to work responsibly, thoroughly and independently; organize one's own work; effectively communicate with clients and colleagues.
