1. Work with electrical hand tools.
2. Maintain simple power and lighting equipment.
3. Read operating schemes of electrical equipment.
4. Read schemes of electrical installation.
5. Perform electrical installation according to blueprints for electricity.
6. Perform electrical engineering work and solder, make connections by crimping or using screws, and cut metal and perform metal work required during the repair and installation of electrical equipment.
7. Take electrical measurements of current, voltage, power, insulation resistance, etc.
8. Install and maintain electrical measurement devices, electric meters, motors, and low voltage power distribution equipment.
9. Identify and eliminate minor breakdowns of power or lighting systems and electrical equipment.
10. Render first aid to injured parties.
11. Observe health and safety requirements.

The holder may perform installation work, maintenance, and repair of power and lighting systems.
