## 3. Profile of skills and competences

After completing this training programme, a person can:

- 1) Illustrate accents of future interior designs and create mood realization rooms;
- 2) Select and compose colour palettes for various premises;
- 3) Design interiors using interior matching techniques;
- 4) Install framework for interior elements;
- 5) Fix plasterboard;
- 6) Clean and wash various surfaces before trowelling works, and use surface preparation tools and electrical devices;
- 7) Fill, smooth and prime various surfaces for painting with necessary fillers and primers;
- 8) Prepare water-based and non-water based paints for surface painting; paint with various water-based and non-water based paints manually and mechanically;
- 9) Prepare various surfaces for wallpapering, select and prepare necessary wallpapers, mark wall and ceiling surfaces, cover different surfaces with various wallpapers and perform wallpapering of more complex surfaces;
- 10) Decorate interiors using basic decoration methods;
- 11) Work safely at high altitudes;
- 12) Install and dismantle scaffolding;
- 13) Describe ways and methods of self improvement.

## 4. Range of occupations accessible to the holder of the certificate<sup>1</sup>

Working at various companies that carry out interior painting and wallpapering; working with a business certificate, or working individually.
