An assistant social worker works with persons in children's homes, health care institutions, rest homes for seniors, residential care homes for the disabled and day centres, rehabilitation institutions, communities, centres of ethnic minorities, parishes, catholic organizations and as a visiting assistant social worker in persons' houses taking care of seniors and the disabled persons. Fields of activities of an assistant social worker: determining a need for individual social services; planning of social services; provision of social services.
